The Breeder has taken every care with breeding, rearing and the welfare of the dog. The puppy is believed to be in good health and is sold in good faith. The Breeder makes no warranty however, as to the health and disposition of the puppy. Every effort has been made to avoid any possible inherited conditions.

Purchaser's Right to Return the dog in the case of a defect.

The purchaser(s) shall have 72 hrs to have the dog examined by a practicing Veterinary Surgeon and shall have the right during a period not exceeding 24hrs after such examination to return the puppy because of a defect (other than described below [A]) on production of a written report from the said Veterinary Surgeon, at which time the purchaser(s) will be refunded the full purchase price.

A) The purchaser(s) hereby acknowledges that the breeder has disclosed the following faults or defects _____ Should it become necessary, the purchaser(s) should be aware that the return of a puppy can be very difficult, especially emotionally and, having drawn the attention of the purchaser(s) to this, the Breeder cannot be held responsible for any distress caused by the return of the puppy. Where possible, an alternative puppy will be offered in exchange.

Potential of the puppy

Although any description of the puppy as being of working, trial or competition quality is given in good faith, it is a condition of this sale that no warranty can be given as to the ultimate working/ trial/showing or any other activity potential at maturity of the dog.

Endorsements [if applicable]

This puppy is sold subject to the following endorsement:

The Kennel Club Pedigree supplied with this puppy has been endorsed by the Breeder 'progeny not eligible for registration'. This is to help protect against the unacceptable use of the puppy for breeding – such as so called 'Puppy Farming'. The new owner of the puppy who wants to breed from her in the future must first obtain permission from Umdlwane Management and then return to Umdlwane and use one of the Umdlwane stud dogs for her first litter at a cost of the stud fee, whatever it maybe at the time. This will ensure that the bitch's first litter will be hereditary clear of the relevant health tests. If the new owner doesn't return to Umdlwane on her first mating the registration endorsement that is in place with the kennel club will not be lifted. After the first litter is born any further litters the owner wishes to have may use any stud dog of their choice.

Re-homing of the dog

The Purchaser(s) agree that if at any stage in the dogs life, the Purchaser(s) need to rehome the dog, the Breeders [Umdlwane] will be the first to be informed and the Purchaser(s) will, if the Breeder requests return the dog to the breeder. This puppy must not be sold or transferred without the prior knowledge and written agreement of the Breeder – the Breeder will always be willing to help, if necessary with the re-homing of a dog that Umdlwane have bred, for whatever reason, throughout the dog's lifetime.
